COVID Conversations – How Does the MN Mask Mandate Affect PCAs & HMs?

The MN Mask Mandate addresses wearing masks in indoor public places, as well as outdoors when social distancing is not possible. The Mandate goes on to flesh out more specific situations when a mask is mandatory. There is a stipulation that states:

"...workers entering another person's living unit for a business purpose are required to wear a face covering when doing so."

(Page 5, Number 9, Letter a, Roman numeral i)

With this in mind, we have shifted from *recommending* wearing a mask to **requiring wearing a mask while working with clients** in accordance with the [Governor's Executive Order 20-81](#).
